LabCard Update

The LabCard program introduced in 2008 continues to provide significant savings to the member and to the Egyptian Trust. When using the LabCard program members receive 100% benefits (except that Bronze Plan members must first meet the calendar year deductible). Meritain continues to work with LabCard to recruit providers to participate as specimen collection sites in areas that are currently limited.

For those members who may not have access to a LabCard contracted facility, LabCard is happy to reach out to your physician's to see if they have the ability to provide a specimen collection in their office and to work with them to send those specimens to Quest Diagnostics for their LabCard patients. Message to **Egyptian Trust Health Plan Members**

There are several upcoming benefit enhancements to the Egyptian Trust Health Plans including the ability to reduce your 2014 calendar year deductible and save on your out of pocket costs when using certain providers for certain procedures. It is important that you carefully review the information contained in this newsletter as you prepare to make changes to the plans or type of coverage you enroll in during the upcoming open enrollment period.

Changes September 1, 2013

The following changes will become effective September 1, 2013 unless otherwise noted.

Change In Plan Names

Under the Affordable Care Act (ACA), all insurance plans sold in the individual and small group insurance markets must have certain prescribed actuarial values. The ACA calls these plans the Platinum, Gold, Silver and Bronze Plans, depending on the value. The plans offered by the Trust are not structured to provide the same actuarial values required for the corresponding insured plans. To avoid confusion, the names of the Trust's plans will be changed to Plan A (formerly Platinum), Plan B (formerly Gold), Plan C (formerly Silver) and High Deductible Health Plan or HDHP (formerly Bronze).

Premium Rates

A premium rate increase of 3.4% will become effective September 1, 2013. The following reflects the current rates and the rates that will become effective September 1, 2013. The rates include \$10,000 of Basic Life insurance.

Health Plan Changes

FLU Vaccine Coverage Out Of Network

Currently flu vaccines are covered only when a covered member uses a HealthLink or in-network provider. In order to encourage members to get the annual flu vaccine, the Trust will now provide coverage for out of network providers. The benefit will be limited to \$40 when using an out of network provider. If a provider (such as a county health department) is not set up to bill insurance for the vaccine, members may submit a claim for reimbursement up to \$40. Exchange Open Enrollment as a Qualifying Change Event

Effective **January 1**, **2014**, and effective each January 1 thereafter, individuals will have an opportunity to purchase insurance coverage on the new state "exchange" or "marketplace." Depending on income level and the coverage offered by the employer, some members may qualify for premium subsidies from the federal government if they purchase coverage on the exchange. The exchange will have an annual open enrollment period at the end of each year for coverage effective the following January 1. The Trust will treat the exchange open enrollment period as a qualifying change event that will allow members to make changes in coverage that are consistent with a change in coverage on the exchange. That is, a member who elects to enroll in an insurance plan through the exchange during an exchange open enrollment period will be permitted to drop Trust coverage as of December 31. A member who was previously enrolled in an insurance plan through the exchange will be permitted to drop that coverage and enroll in one of the Trust's plans effective January 1.

Member Note: You will be responsible for providing documentation to the employer that your decision to enroll in or drop coverage through the Trust corresponds to your decision to enroll in or drop coverage through the exchange.

Employer Note: You will be responsible for confirming that the member's decision to enroll in or drop coverage through the Trust corresponds to the member's decision to drop or add coverage purchased through the exchange.

Voluntary Health Plan Programs

Consult A Doctor™ Program To Be Offered On A Voluntary Basis



The Egyptian Trust will continue to offer the Consult a Doctor program. This program is free of charge to you when you are enrolled in one of the Health Plans. This program provides members with unlimited access to experienced state-licensed physicians by telephone or e-mail. Doctors are available to provide advice around the clock, including weekends, holidays or after business hours, and can prescribe medications for common conditions such as allergies, bronchitis, cold/flu, headaches, respiratory and sinus infections, stomach ache/diarrhea, urinary tract infections and many other conditions. This program is not intended to substitute a patient's own physicians, but provides an alternative to Urgent Care or Emergency Room care when the patient is traveling, needs to reach a physician after normal business hours, etc. This program can help avoid unnecessary office visits or Emergency Room visits and offers the covered member an alternative while still having the ability to consult with a physician. This program has been very popular with members and has resulted in reduced utilization of costly Emergency Room services.

Employees and their families who are covered by one of the Egyptian Trust Health Plans will continue to be enrolled in this program at no additional fee.

The Egyptian Trust will now offer Consult A Doctor as a voluntary benefit so that district employees and retired employees who are not enrolled in one of the Trust's medical plans can access this benefit by paying the monthly premium of \$2.56. At this time, only employees may participate in the Consult a Doctor program on a voluntary basis.

Healthcare Blue Book

If you are like most people, you probably have a pretty good idea of what you are going to pay when you go grocery shopping, or when you need to replace your cell phone. However, change the conversation from everyday purchases to the topic of healthcare prices, and we are all pretty much in the same place – the dark. Charges by different providers for the same service or procedure can extremely vary, often by several hundred or even several thousand dollars, with little or no difference in quality.

Healthcare Blue Book is an online tool that can help you better understand what you should pay for healthcare procedures, as well as find providers offering fair prices in your area.

This is a FREE service, and is accessible through the Trust website at www.egtrust.org by clicking on the following logo on the Home Page. Members may also contact the Care Coordinators at 855-452-9997 for assistance.



Members will enter a specific service or procedure on the website and the program will bring up a list of providers within the geographical area that provide the specified service. The provider list will be sorted by cost, with the lowest cost providers listed first in the "green zone", followed by higher cost providers shown in the "yellow zone" and "red zone". The tool will show the range of costs charged by each provider for the service and also shows what Healthcare Blue Book has determined is a reasonable cost for the service.

To encourage members to use the Blue Book tool and choose lower cost providers, the Trust will offer cash incentives for using green zone providers for certain procedures. When a member has one of the procedures listed below performed by a "green zone" provider, the member will receive a check in the specified amount.

Wellness Initiative 2013 - 2014

If you are a member covered by one of the Egyptian Trust Health Plans you should have received a document at your home address outlining the 3 simple steps you need to take by September 30, 2013 in order to qualify for the incentive in 2014. As a reminder, completing the 3 simple steps will afford you a reduction of \$100 of your calendar year deductible in 2014 if you have employee only coverage and up to a \$300 reduction of your family calendar year deductible if you cover dependents. If you cover yourself and one dependent your calendar year deductible will be reduced by \$100 for both you and your one covered dependent, or \$200. If you cover yourself and two or more dependents, each covered person's calendar year deductible will be reduced by \$100, not to exceed \$300 per family. This applies to those enrolled in Plan A (formerly Platinum), Plan B (formerly Gold), or Plan C (formerly Silver). Employees enrolled in the High Deductible Health Plan (formerly Bronze) will pay 10% less after the calendar year deductible is satisfied (the co-insurance level will increase by 10% for you and your dependents enrolled in this Plan). Please note that IRS requirements prohibit reduction of the calendar year deductible for a High Deductible Health Plan.

In order to be eligible for the incentive, participation is required by Egyptian Area Schools <u>employees only.</u> (This includes retired employees and individuals covered by COBRA.) Dependents do not need to complete the requirements.

Three simple steps:

- 1. Designate a Primary Doctor and enter online.
- 2. Complete your biometric screening and enter your results online.
 - Your biometrics screening results include height, weight, blood pressure, total cholesterol, LDL, HDL, triglycerides, and glucose. If you've already visited your Primary Doctor, your biometrics screening results must have been obtained between September 1, 2012 and September 30, 2013.
 - There are several ways to obtain your biometrics results:
 - Visit your Primary Doctor.
 - Obtain a prescription or order for blood work from your Primary Doctor and take it to a Lab Card facility.
 To locate a Lab Card facility, go to www.labcard.com.
 - Visit your county health department or other out-of-network provider. Egyptian Trust will pay up to \$75 of the cost.
 - o Onsite screenings may be an option for some districts. Your administration will communicate if this is available to you.
- 3. Complete your Wellness Assessment (HRA) online.

You will complete the above 3 steps by going to www.egtrust.org, clicking the Egyptian Area Schools Coordinated Health/Care logo.

Then, under Health & Wellness, click "Your Incentive Checklist" and log on or register and follow the instructions to complete the above requirements. All results must be reported to *Coordinated Health/Care* by September 30, 2013 in order to qualify for the incentive.
