What is the overall deductible?	For In-Network: \$2,100 Individual/\$4,200 Family For Out-of-Network: \$4,200 Individual/\$8,400 Family	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , the family <u>deductible</u> must be satisfied before the <u>plan</u> will pay expenses for any covered family member, except <u>preventive services</u> .
Are there services covered before you meet your deductible?	Yes. Certain <u>preventive care</u> is covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply.
